



Dear Storage Customer:

Believe it or not it is time once again to begin planning for your indoor winter storage needs. The in-take dates for the 2019-2020 storage season begins on Saturday, October 12, 2020 and will continue through Saturday, October 26, 2020. Once again, we will be offering a 5% "Early Bird Discount" for anyone paying in full prior to the close of business on September 27, 2020.

The Lucas County Fairgrounds is an excellent choice for your vehicle's indoor storage needs. The indoor storage can accommodate almost any size car, motorcycle, boat, trailer, camper or motor home up to and including size Class "A".

The new storage contract can be found on our website at: LucasCountyFair.com for anyone new to storage. There are several options this year for completing your contract. There is an on-line form that can be completed and emailed to fairoffice@LucasCountyFair.com, mailed via USPS or dropped off at the fair office. Please include "Storage Contract" in the subject line. For all returning customers, please call the fair office and we will prepare your contract. Remember to enclose your payment if you want to take advantage of the "Early Bird Discount". All vehicles must be paid in full and a copy of your insurance in the fair office before you will be guaranteed a spot in our buildings. If you do not get your paperwork completed and we fill you will miss out.

The following dates will be available for drop-off /in-take:

Saturday, October 12
Saturday, October 19

All in-take hours will begin at 9:00 a.m. and end PROMPTLY at 1:00 p.m.

- ALL vehicles will first enter the inspection area located in the parking lot next to the Fair Board Office for a brief in-take inspection consisting of photographs, determination of length and vehicle inspection.
- Next, the owner will sign the final contract in the Fair Board Office where **Proof of insurance (Insurance Declaration Page) will be mandatory.** You will receive your storage tag at this time and you will attach it to the tongue of the hitch/trailer.
- Last step will be unhooking their vehicle and owner's final inspection of the item being stored.

Out-date/pick-up dates are:

Saturday, April 11, 2020
Saturday, April 18, 2020
Saturday, April 25, 2020

All out-take hours will be from 12:00 a.m. to 3:00 p.m.

To ensure an easy and smooth out-take, this will be determined by the building being stored in. Any vehicle not picked up by close of out-take hours will be restored and a mandatory \$25 restoring fee will be assessed.

STORAGE RATES:

- All cars and light trucks \$215 (entire storage time)
- All motorcycles \$180 (entire storage time)
- Vehicles, including trailers, boats, campers, motor homes, jet skis on trailers, etc. will be charged as follows for the entire storage season:
 - 01 to 30 feet = \$12 per foot
 - 31 to 35 feet = \$14 per foot
 - 36 and over = \$16 per foot

(Example: 31 foot boat x \$14 would total \$434 for the entire season)

- 7 ¼ % Sales Tax will be added.
- There is a \$2 fee for paying with a credit card.
- All measurements will include tongue length to end of trailer or outboard motor.
