

### 2023 Lucas County Fair STEM Pavilion Exhibitor Timeline & Rules

#### **EXHIBIT TIMELINE**

- Set up for Exhibitors is scheduled for Monday, July 10. Doors will open for setup at 8am.
- Setup must be complete by Tuesday (7/11) at 10am.
- Exhibitors must attend booths daily (Tuesday Friday) from 11am to 6pm.
- Exhibitors may attend outside of these hours if they prefer. (Fair open 9am to 10pm)
- No displays are to be dismantled or removed prior to the Fair's closing on 7/16 at 5pm.
- Teardown begins Monday (7/17) at 8am.

#### **EXHIBITOR RULES**

- 1. Participants must conform to event set up, opening, and closing times and all entry/exit patterns.
- 2. All booths must be paid in full at time of registration. To promote fairness to all participants, contracts received without payment cannot be accepted as a reservation for space. No refunds will be issued except at the discretion of Lucas County Fair.
- 3. A service charge of \$25 will be assessed for any check that is returned for insufficient funds or other causes.
- 4. Lucas County Fair reserves the right to assign booth spaces to exhibitors. Exhibitors may not assign, sublet, or apportion space, nor exhibit or advertise goods other than their own. Assigned spaces are limited to the business or organization registered for that space. No sharing or swapping of booths.
- 5. Exhibitor booths are 10 ft wide by 20 ft deep; Student organization spaces are 10 ft wide by 10 ft long. Adjacent booths may be configured in any way, so long as no part of the display extends beyond the bounds of the booths included in the agreement.
- 6. Exhibitors should bring their displays. One table and two chairs will be provided.
- 7. Exhibitors are responsible for the installation and removal of their own displays.
- 8. Exhibitors are always solely responsible for all items in their booth. Please do not leave booths unattended or unsecured.
- 9. All Exhibitors will be required to park outside of the festival area. Parking passes will be provided upon request.
- 10. All Exhibitors must confine their activities, merchandise, literature, souvenir items, equipment and personnel to the space allotted them. No signs or advertising devices shall be displayed outside of the exhibit space or extend into the aisles or neighboring booths. Signs or displays must not obstruct the view or adversely affect the displays of other exhibitors. Refrain from putting literature on cars in parking lots.
- 11. Exhibitors may not offer food nor drink, either on a complimentary basis or for sale, with the exception of small, wrapped candy at no cost.
- 12. Electrical service can be provided upon request for no additional cost.
- 13. Megaphones, microphones, loud music, or shouting will not be permitted.
- 14. Exhibitors must be in compliance with all Federal, State, City of Maumee, and Lucas County ordinances.
- 15. Lucas County Fair reserves the right to restrict exhibits to suitable methods of operation and display of materials. If for any reason an exhibit or its content is deemed objectionable by the show's management, the exhibit is subject to removal. In such an event, management will not be liable for refunding fees paid for exhibit rental except at its own discretion. Lucas County Fair may remove any person or vendor who does not comply with the rules and regulations stated herein or who fails to obey any lawful order of the Lucas County Fair or its designee.
- 16. Lucas County Fair reserves the right to decline any application for entry.
- 17. Lucas County Fair reserves the right to amend the festival rules at any time as it deems appropriate.
- 18. Final booth assignments and set up instructions will be available 7 days prior to the event.
