This privilege is accepted upon condition that the business stated above is to be conducted in accordance with the Rules and Regulations of the Lucas County Agricultural Society and further that the Purchaser of the Contract pledges, agrees, and offers to the aforesaid Society any and all structures occupied or erected by him, her, or them, all goods, implements or appurtenances which are used in transacting the business in this privilege pertains, as a Guarantee for the payment of the sum herein stated, in the case of such forfeiture, said Society shall have the privilege of offering the same at Public Auction, and apply enough of the proceeds from such sale to the discharge of the amount due. The location of said privilege is to be assigned by the Fair Coordinator/Manager, and the business of running such privilege is to be conducted to the satisfaction of the Fair Coordinator/Manager. Retention of this contract on the part of the purchaser will be taken as evidence of acceptance. The Lucas County Agricultural Society assumes no responsibility for the loss or damage of the Lessee's property. The privileged space is provided for the Lessee, and full payment is due to the Society if used or not used. Contract subject to Lessee securing a license from the Department of Agriculture of the State of Ohio (if required)—no exclusive privileges granted by the Society. Written notice must be received prior to April 1: 50% deposit will be refunded. No refunds if notification is received after April 1.

Each Contractor/Vendor shall obtain and keep in force until completion of the "project (fair)," including set up and tear down, a commercial general liability insurance contract with liability limits equal to or greater than \$1,000,000 each occurrence. The contractor/vendor shall **provide a certificate of insurance** to the **Lucas County Agricultural Society** evidencing such coverage within ten days of the signed contract. Such Contractor shall **name Lucas County Agricultural Society and Lucas County Commissioners as Additional Insured.**

Hold Harmless/Indemnification: Contractor/Vendor shall be solely responsible for any and all injuries to persons or damages of property or any other injury, claim, damage, or loss of whatever nature, arising directly or indirectly from the "project." Contractor shall **INDEMNIFY, SAVE AND HOLD HARMLESS Lucas County Agricultural Society and Lucas County Commissioners** and its employees, agents and volunteers from and against all liability, loss, damages, claims, costs and expenses (including attorney fees) arising out of injury to person or damages to property or any other injury, claim, damage, loss, cost or expense arising from the "project/fair."
