Any item not removed by April 15, 2027, will incur a daily storage rate of \$10.
If any item is left past April 15, 2027, and the item needs to be relocated, the Lessee shall be responsible for any costs associated with moving the storage item, i.e., towing rates, labor rates, etc.
It is the Lessee's responsibility to remember and abide by the April 15, 2027, removal date, regardless of whether contacted or not, unless prior approval is granted.

No vehicle will be released until all outstanding fees are paid.

Terms of Storage Contract

1. **Dates:** The term of this agreement shall begin upon signing.
2. **Fees:** In consideration for allowing storage on the Lucas County Fairgrounds, the Lessee agrees to pay the amount payable no later than the intake date.
3. **Late Fees:** The Lessee may be charged a \$25 restocking fee per week if the item is not removed on the assigned out-take date. If any storage item is left past April 15, 2027, and it needs to be relocated, the Lessee shall be responsible for any and all costs associated with moving the item, i.e., towing rates, labor rates, etc.
4. **Value:** The lessee hereby declares, warrants, and represents that to the best of the lessee's knowledge and belief, the vehicle is of fair market value.
5. **Loss and Damage:** The Lucas County Agricultural Society makes every attempt to avoid loss and/or damage during vehicle intake, storage, and out-take.
The Lucas County Agricultural Society assumes no liability for loss, damage, or destruction of any kind to the vehicle, whether due to collision, fire, vandalism, theft, weather, or otherwise. It is possible for birds to get into the buildings and/or rodents. We are not responsible for any damage caused by nesting/flying birds or rodents.
6. **Insurance:** *The Lessee, at his/her own expense, shall provide private insurance coverage for their vehicle. All lessees shall provide a copy of their Insurance Declaration Page to the Fair Board Office prior to intake.* The Lucas County Agricultural Society does NOT insure vehicles during the storage period. The lessee is also responsible for any damage to other vehicles, building(s), property, or personnel caused by their vehicle.
7. **Inspections:** All items shall be inspected prior to intake. All vehicles shall be uncovered to allow for complete inspection and photographs.
8. **Batteries:** All batteries shall be disconnected at the time of storage.
9. **Floor Covering:** All vehicles shall have a floor covering (carpet, tarp, wood, cardboard, etc.) to avoid oil or other fluid damage caused by the vehicle. A \$50 clean-up fee for any floor damage caused by fluid leaks from the lessee's vehicle will be charged.
10. **Out-Take:** Vehicles will be removed from storage buildings and relocated to an outside designated location for pickup.
11. **Early Removal:** A \$200.00 fee will be imposed if any owner requests to remove a storage item before the take-out date.

The Lessee shall sign and acknowledge the Terms of Storage Contract.

All cars and light trucks – \$242.44 (entire storage season)

All motorcycles & golf carts – \$193.95 (entire storage season)

Vehicles, including trailers, boats, campers, motor homes, jet skis on trailers, etc., will be charged as follows for the entire storage season:

0-15ft	\$226.28
16-19ft	\$286.62
20-23ft	\$346.96
24-27ft	\$407.30
28-30ft	\$452.55

31-33ft	\$565.69
34-36ft	\$619.56
37-39ft	\$668.05
40-42ft	\$727.31
43-45ft	\$781.19

All measurements will include tongue length to the end of the trailer or outboard motor.

Contracts are subject to a 7.75% sales tax (already included), and a credit card processing fee (when applicable).

Any item brought in before October 1, 2026, is subject to a \$25 early fee.

Any item brought in after November 1, 2026, is subject to a \$25 late fee.

For an additional \$50, it can be kept in storage until May 15, 2027, or June 15, 2027, for \$100.
